- 2. The finance for this programme will be accountable as Official Development Assistance (ODA). As ODA funding, the funds will need to prioritise livelihoods, poverty alleviation and climate in ODA-eligible countries.
- 3. Appropriate and proportionate safeguarding measures are in place and will be maintained, including but not limited to those outlined in UNEP's Environmental, Social and Sustainability Framework Safeguard Standards<sup>1</sup>; and complaints raised by stakeholders will be addressed as per UNEP's Stakeholder Response Mechanism<sup>2</sup>. Defra and UNEP have a zero tolerance for inaction approach to tackling sexual exploitation and abuse ("SEA") and sexual harassment ("SH") and agree to the terms set out in Annex C.
- 4. The Contribution recipient agrees to provide the Authority with a narrative report, in accordance with Annex D section c) Report confirming Delivery and the Certificate of Contribution Usage within 30 days after the Contribution term has expired. The Contribution recipient also agrees to provide to the Authority with a completed Statement of Expenditure, in accordance with Annex D, within 6 months after the Contribution term has expired.
- The Contribution will be received, managed, disbursed, accounted for and audited in accordance with the applicable Financial Regulations and Rules of the United Nations.
- 6. You agree that no activity supported by this Contribution will bring DEFRA's name into disrepute.
- 7. You agree to ensure that DEFRA's Contribution will be spent only upon properly incurred expenditure which provides value for money for DEFRA.

- 8. If you do not comply with any of the conditions and requirements of this Contribution agreement, DEFRA may require all or part of the Contribution to be repaid.
- 9. You acknowledge that the Contribution is not consideration for any taxable supply for VAT purposes by DEFRA to you. You understand DEFRA's obligation does not extend to paying you any amounts in respect of VAT in addition to the Contribution and that the Contribution which is made by DEFRA is inclusive of VAT.
- 10. You shall not carry out any activities that could be constituted as state-aided nor shall you pay illegal state aid to any organisation or individual, in accordance with the UN financial rules and regulations.
- 11. If agreed by both the Authority and Contribution recipient in writing, then a no cost extension may be enacted for a maximum of 6 months.

### **Termination**

The following UN rules shall apply in regard to termination/expiry of the Contribution:

#### Article VIII

UNEP shall notify the donor Government when, in its opinion, the purposes for which the funds were contributed have been realised. The date of such notification shall be deemed to be the date of expiration of this Agreement, subject to the continuance in force of Article X for the purposes there stated. Expiration of this Agreement is due to take place on 31/03/2025.

#### Article IX

This Agreement may be terminated by either party on (90) days' written notice to the other party, subject to the continuance in force of Article X for the purposes there stated.

#### Article X

On termination or expiration of this Agreement under Article VIII or IX, the funds will continue to be held by UNEP until all expenditures it has incurred have been satisfied from such funds. Thereafter, any surplus remaining shall be disposed of as indicated by the donor Government.

# Annex A - Project Proposal

#### UNEP/YEA

Tide Turners Plastic Challenge Badge "phase 5"

#### List of key planned activities:

Summary: The GBP 300,000 allocation aims to develop the advocacy training further and continue the delivery in a limited number of current target countries, with main focus on India.

Partners: Captain Planet Foundation (CPF), World Association of Girl Guides & Girl Scouts (WAGGGS), WWF India and CEE India.

Reach: Minimum of 20,000 new participants have registered to the Tide Turners programme (focus on India) and the process has been set up to reach 20 new advocacy champions through a Hero Level training.

#### Deliverables\*:

#### Advocacy:

- 1 new Hero level Advocacy training designed and 5 Hero Level Training Hosts identified and contracted in strategic regions.
- Number of youth-led community projects funded.
- Deepen and scale up Tide Turners advocacy training, through e.g. peer-topeer training program to provide local training and mentorship for Tide Turner Heroes.
- Conduct institutional gap analysis to identify opportunities and barriers to meaningful youth engagement in policy dialogues & develop practical tools and solutions to overcome these barriers.
- Start to plan and develop policy training cohorts for Tide Turners in priority regions to engage youth in meaningful activation around the UNEA resolution on plastic pollution.

#### India delivery

- Develop the "Rural model" further in India and revise challenge activities for under represented communities.
- Develop resource material including educational content and outreach material for the TTPC in India.
- Communications:

- Tide Turners event organized to celebrate the success of the programme and the launch of the "Blue Planet Phase".
- Support the design and creation of the Tide Turners App (GEF funded project) to increase the reach and impact of the programme, to explore peerto-peer learning, better monitor progress, and to have better access to data and success stories from communities.
- Assessment of performance will include the Blue Planet Fund KPIs relating to i)
  volume of finance mobilised and ii) increased inclusion of marginalised and/or
  vulnerable groups. Both KPIs will be based on indicators that admit wide-ranging
  forms of data collection.

# Annex C - Harmonised language on tackling SEA and SH

#### 1. a. Sexual exploitation and abuse

Defra and UNEP have a zero tolerance for inaction approach to tackling sexual exploitation and abuse ("SEA").<sup>3</sup> This means UNEP and its implementing partners will take all reasonable steps to prevent SEA by both its employees and any implementing partner and respond appropriately when reports of SEA arise, in accordance with their regulations, rules, policies and procedures.

Unless inconsistent with a specific regulation, rule, policy or procedure governing UNEP, UNEP will apply the IASC Six Core Principles Relating to Sexual Exploitation and Abuse (Annex I) and the following principles and practices when implementing the activities under this arrangement and provide evidence to demonstrate this where required:

- a) Adherence to the IASC-Minimum Operation Standards on "Protection from sexual exploitation and abuse by own personnel" and/or [the] SEA elements of the Core Humanitarian Standard on Quality and Accountability;
  - b) A victim/survivor-centred approach<sup>4</sup> to SEA issues;
  - c) Strong leadership and signaling on tackling SEA;
  - d) Make all reasonable efforts to address gender inequality and other power imbalances;
  - e) Reporting to enhance accountability and transparency;
- f) Ensure that SEA standards from this arrangement are reflected in funding templates with implementing partners, [for UN entities: by means such as, but not limited to, adherence to the United Nations Protocol on Allegations of Sexual Exploitation and Abuse Involving Implementing Partners].

#### b. Sexual harassment

Defra and UNEP have a zero tolerance for inaction approach to tackling sexual harassment ("SH").<sup>5</sup> This means UNEP will take all reasonable steps to prevent SH and respond appropriately when reports of SH arise, in accordance with its regulations, rules, policies and procedures.

Consistent with the UN Protocol on Allegations of SEA Involving Implementing Partners, the victim/survivor should be informed, consulted during the decision-making process, and provide consent on the possible use and disclosure of their information. Those interacting with the victim/survivor and/or handling information regarding the allegation will maintain confidentiality, ensure safety of the victim/survivor, and apply victim/survivor-centered principles which are safety, confidentiality, respect, and non discrimination. When the victim/survivor is a child, the approach will consider the best interests of the child and engage with the family/caregivers as appropriate. Staff and partners should comply with host country and local child welfare and protection legislation and international standards, whichever gives greater protection.

Unless inconsistent with a specific regulation, rule, policy or procedure governing UNEP, UNEP will apply the following principles and practices when implementing the activities under this arrangement:

- a) A victim/survivor-centred approach to SH issues;
- b) Strong leadership and signalling on tackling SH;
- Make all reasonable efforts to address gender inequality and other power imbalances;
- d) Reporting to enhance accountability and transparency;

#### 2. UNEP will adhere to the following requirements:

#### a. Allegations of SEA

- (i) UNEP will promptly report all allegations of SEA credible enough to warrant an investigation through the Secretary-General's reporting mechanism (the "Report").
- (ii) When UNEP reports an allegation of SEA to, or becomes aware of an allegation reported through, the Report that is (i) directly related to the activities funded by this arrangement or, (ii) would have a significant impact on the partnership between UNEP and Defra, UNEP will promptly notify <a href="mailto:oda.safeguarding@defra.gov.uk">oda.safeguarding@defra.gov.uk</a> of the report made and the relevant arrangement number, if applicable and provide information containing the level of detail that UNEP is aware of.
- (iii) Upon request from Defra, UNEP agrees to provide further available relevant information UNEP is aware of for allegations notified under paragraph 2(a)(ii) including about subsequent measures taken by UNEP, unless disclosure of such information would be inconsistent with UNEP's regulations, rules, policies and procedures concerning disclosure of information.

### b. Allegations of SH

- (i) UNEP will report allegations of sexual harassment and measures taken through existing reporting mechanisms.
- (ii) Where UNEP has determined that the allegations would have a significant impact on the partnership between UNEP and Defra, UNEP will promptly notify <a href="mailto:oda.safeguarding@defra.gov.uk">oda.safeguarding@defra.gov.uk</a> and provide information containing the level of detail of the existing reporting mechanisms.
- (iii) Upon request from Defra, UNEP agrees to provide further available relevant information, that UNEP is aware of unless disclosure of such information would be inconsistent with UNEP's regulations, rules, policies and procedures concerning disclosure of information.
- 3. It is understood and accepted that UNEP's arrangement to report on SEA and SH will be performed in accordance with UNEP's regulations, rules, policies and procedures, including its rules on confidentiality, and is subject to not compromising the safety, security, privacy and due process rights of any concerned persons.
- 4. When UNEP becomes aware of reasonable suspicions, complaints or reports of SEA or SH by its personnel, UNEP will, as appropriate under its regulations, rules, policies, and procedures, take reasonable, swift and appropriate action to stop harm occurring.

- investigate and report to relevant authorities (for potential criminal matters), as appropriate and when safe to do so, after considering the wishes of the victim/survivor.
- 5. Defra or any of its duly authorized representatives may, in accordance with agreed mutually accepted terms of reference, carry out reviews or evaluations or other assessment measures to verify UNEP's zero tolerance for SEA and SH, provided that such measures are consistent with the single audit principle governing the UN, if applicable. UNEP will fully cooperate within the scope of the terms of reference with any such reasonable requests by Defra or any of its duly authorized representatives or agents to carry out such measures.
- 6. Any information or documentation provided in accordance with these provisions will be treated by Defra with utmost discretion in order to ensure, inter alia, the probity of any investigation, protect sensitive information, ensure the safety and security of persons and respect the due process rights of all involved. Defra will presume information/ documentation to be confidential, deliberative, and investigatory and will ensure that information/documentation provided to Defra will be available solely to those who strictly require access to such information/documentation. Any disclosure of such information/ documentation beyond such personnel will require notification and consultation with UNEP. Defra will obtain the express written authorization of UNEP before disclosing any such information/documentation in a judicial proceeding or to the public, unless disclosure is otherwise required by law applicable to Defra and is not subject to UNEP's privileges and immunities under international and/or national law (such as information/documentation constituting UN archives).
- 7. Unless the regulations, rules, policies, and procedures applicable to UNEP are amended at an earlier stage, and/or there are other substantive changes to any of the referenced policies, processes or mechanisms, the above provisions are subject to possible review two years after the date of Defra's mutual decision on their text with UNEP. Any changes to the above provisions that may be mutually decided following such a review will take effect at least four years after the date of Defra's mutual decision on the present text with UNEP, until which time the above provisions will continue to apply.
